To qualify for dual enrollment, students must:

- › Submit an online application
- › Submit a current high school transcript reflecting a 3.0 or higher GPA
- › Provide standardized test score of 1030 (SAT) or 22 (ACT) or
 - Keystone/PSSA at the proficient or advanced range for Math and/or Reading and/or Writing Tests
 - Satisfy any course prerequisites prior to registration. In order to enroll in an English course, a student will need to take a written placement test given by ESU's English department.
- › Check with your high school counselor to determine if the college course will be counted toward high school graduation credit requirements
- › Request and receive approval from parents/guardian and guidance counselor or school principal. Student will need to provide an e-mail address for parent/guardian and high school official in order to submit the approval requests electronically
- › Provide evidence that they have been appropriately immunized upon admission to ESU
