The times listed on the charts below are to be considered as the official times indicating:

- 1. Start and end of the school day
- 2. When children are considered tardy
- 3. When to list a child present

Absence – Students attending less than half (1/2) of the school day will be considered absent for the full day.

Attendance secretary will note the starting, ending and tardy times in the system.

1. When an **elementary** student arrives at school after their start time, but prior to their tardy time, the child is counted as tardy.

- 2. When an **elementary** student has an early dismissal after **12:25 PM (CREC, CRIS, SEC, SIS, TEC)**, there should be an (ED) early dismissal code in the computer. They will get credit for a whole day of attendance.
- 3. Whenever a child has an early dismissal, they should be signed out in the office where the attendance secretary is located, even when they are sent home by the nurse.
