a. Universal and correct wearing of masks;	 On December 10, 2021, the Pennsylvania Supreme Court rescinded the Acting Secretary of Health's school masking order. Please note that this decision does not impact the federal directive requiring all passengers and drivers to wear a mask on school buses, including on buses operated by public and private school systems. From this day forward, Pocono Mountain School District will not be mandating mask wearing. On February 25, 2022, the CDC announced effective immediately, masks are no longer required on buses or vans operated by public or private school systems, including early care and educational/child care programs. If the guidelines change the district will adhere to the masking on transportation. All employees shall remain socially distant to the maximum extent feasible. All students shall remain socially distant to the maximum extent feasible. Provide standard PPE for all staff and students as needed. All employees shall remain socially distanced to the maximum extent feasible. All students shall remain socially distanced to the maximum extent feasible throughout the school day. Teachers will continue utilizing seating charts. Provide standard PPE for all staff and students as needed.

c. Handwashing and respiratory etiquette;	• • • •	Students and staff will be instructed in and adhere to current PA DOH and PDE guidelines for handwashing and respiratory etiquette. Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, use hand sanitizer that contains at least 60% alcohol (for staff and older children who can safely use hand sanitizer). Avoid touching your eyes, nose, and mouth.
	• •	Cover coughs and sneezes with a tissue or cough or sneeze into your elbow. Used tissues should be thrown in the trash can and hands should be washed immediately with soap and water for at least 20 seconds. Buildings will maintain proper temperature and ventilation during occupancy.

2022-2023 PMSD COVID Guidelines

Students, teachers, and staff who have symptoms of COVID-19, should stay home and speak to a healthcare provider regarding testing for COVID-19. Staying home when sick with COVID-19 is essential to keeping COVID-19 infections out of schools and preventing the spread to others.

Staff members who test positive for COVID-19:

- Immediately notify the Human Resources department.
- work on day 6 provided they continue to mask for days 6-10. Isolate at home for at least 5 days from date of symptoms or date of positive test result (if asymptomatic) and can return to
- If you test positive but do not have symptoms, you are still required to quarantine for at least 5 days and can return to work on day 6 provided they continue to mask for days 6-10.

Students who test positive for COVID-19:

- Parents please immediately contact the school nurse or administrator to alert the district of your child's Positive status
- Students will be required to isolate at home for at least 5 days and can return to school on day 6 provided they continue to mask for days 6-10.
- If a child tests positive but does not have symptoms, he/she is still required to quarantine for 5 days and can return to school on day 6 provided they continue to mask for days 6-10.
